



Terms and Conditions

This prize draw is a promotion of SGB Services Limited.

1. The closing date for all entries is 30th October 2008.
2. A maximum of one entry per person is allowed.
3. Three prizes will be offered to three winners who will be notified in writing at the address notified by the entrant within seven working days of the draw date.
 - 1st prize goes to the 1st person/name drawn at random from all those who have entered into the prize draw. 1st prize is two flight tickets from the United Kingdom to a choice of Milan, Paris or Barcelona and up to 4 nights hotel stay for two people up to a maximum total value of £900. The winner will be given a choice of his/her preferred destination and departure dates subject to availability and budget restraints. (See the further 1st Prize terms and conditions at the end of this document.)
 - 2nd prize goes to the 2nd person/name drawn at random from all those who have entered into the prize draw. 2nd prize is an iPod touch, 8gb.
 - 3rd prize goes to the 3rd person drawn at random from all those who have entered into the prize draw. 3rd prize is an iPod nano, 4gb.
4. The prize draw is open only to UK residents aged 18 years or over at the closing date.
5. Employees and contractors of SGB, its affiliated companies or any persons directly or indirectly involved in the organisation or running of the prize draw or their family members are not eligible for entry.

7. If the advertised prize is not available at the time the prize is to be awarded or otherwise cannot be awarded for reasons beyond our reasonable control we reserve the right to substitute a prize of equal or greater value selected by us at our discretion.
8. SGB reserve the right to withdraw or amend the prize draw, at any time, without notice in response to relevant circumstances beyond our reasonable anticipation or control.
9. The winner agrees to the use of their name and image in any promotional activity following the prize draw.
10. No responsibility is accepted for ineligible or fraudulent entries. Entries made fraudulently or in breach of these terms and conditions or which contain material errors are ineligible or liable to be disqualified
11. No purchase is necessary to take part in this free prize draw.
12. Prizes may not be transferred and no cash alternative is available.
13. The promoter's decision is final and no correspondence will be entered into.
14. Entrants agree that we may retain any information provided by them before and for a reasonable period after the prize draw for the purposes of and in connection to the same.

Further 1st Prize Terms and Conditions

1. When we notify the person drawn first at random (“the winner”) that they have won the 1st Prize (“the prize”), the winner will be asked to write to us within 10 days to give us their order of preference for the 3 specified European flight destinations and also some preferred dates for up to 4 consecutive 5 day periods before 30th July 2009 during which they will be available to travel to and stay at the destination, and also preferred departure airport.
2. Within 10 days of receiving the preferences of the winner, we will select and propose in our absolute discretion and notify to the winner in writing dates for and details of flights (standard or economy class) departing from a UK airport to and of hotel accommodation at one of the destinations (“the Offered Prize Details”). In selecting the Offered Prize Details to be proposed we may communicate further with the winner and will take account of and use reasonable efforts to accommodate but shall not be bound to meet the preferences expressed by the winner.
3. The availability of the prize is subject to the flights to and hotel accommodation at the destination being reasonably available for the periods nominated by the winner within the proposed maximum budget of £900. If we are unable within the budget or for any other reason beyond our reasonable expectation or control to offer what we consider to be suitable Offered Prize Details we may in our discretion offer an alternative prize of equal or greater value.
4. The winner will need to confirm promptly receipt and acceptance of the Offered Prize Details within the timescale required to enable us to book the flights and hotel accommodation and to provide contact details for this purpose. In order to be entitled to receive the prize, the winner must confirm receipt and acceptance

of the Offered Prize Details. We reserve the right to re-draw the 1st prize if the winner fails to accept the Offered Prize Details within a reasonable period.

When we receive the winner's confirmation and acceptance of the Offered Prize Details we will (subject to their continued availability) book and pay for the flights and hotel accommodation specified in the Offered Prize Details and confirm the bookings to the winner with details of any arrangements necessary for the winner to collect the flight tickets.
6. Our obligation in relation to the prize is completed when we confirm the bookings of the flights and hotel accommodation. We shall have no further responsibility or liability of any kind in relation to the prize. In particular but without limiting the generality of the previous sentence, it shall be the responsibility of the winner at the winner's cost: to arrange travel to and from the relevant UK airport and to and from the destination airport to the hotel and to pay all other costs and expenses in relation to their stay at the destination or otherwise in relation to the prize; to ensure that the winner (and any person traveling with the winner who we shall have no responsibility to or for) has a valid passport and all other necessary visas or permissions required to travel to the relevant destination and to take all necessary and appropriate actions to ensure their medical fitness to travel to the destination and their health and safety while traveling and during their stay at the destination. The winner agrees to and shall take out appropriate holiday and medical insurance in respect of the arrangements covered by the Offered Prize Details before travelling to the relevant destination and shall provide us with full details of such insurance on request and in any event upon the occurrence of any event which does or might give rise to a claim under such insurance.

When proposing the Offered Prize Details we will endeavour to identify and select flights and hotel accommodation of a satisfactory and reasonable standard but we will be unable to control or verify the quality of what will be provided to the winner or its suitability for the winner's expectations or requirements or whether the services provided will correspond to any standard indicated by or to be expected from the persons delivering the same. The winner acknowledges and agrees that our responsibility is limited to booking and paying for the Offered Prize Details and that we shall have no other responsibility or liability for nor

make any representations or give any warranties concerning the prize. We shall have no responsibility or liability for the actions or service of any third party.
